

# OLD TAUNTONIANS & ROMSEY CRICKET CLUB (incorporating EAST TYTHERLEY CC)

## CLUB REGULATIONS

1. The Club colours shall be royal blue, black and old gold.
2. Subscriptions – these are due on April 1<sup>st</sup>. Because the Club has a licensed Bar, a minimum subscription of £10 (full member non-playing subscription) must be paid before the 1<sup>st</sup> May. The remainder may be paid later. Subscriptions fully paid before the 1<sup>st</sup> May will be at a discounted rate to be decided at an AGM.  
Colts subscriptions will be due on 1<sup>st</sup> February.
3. Parents or guardians of Colts (under 18) members will automatically be Associate members of the Club.
4. Family membership – a Colts player whose parent/guardian is a full playing member of the Club will pay a reduced subscription to be decided at the AGM.
5. New members will have one month after playing their first match to pay their subscription at the reduced rate.
6. The Annual General meeting will be held in November.
7. The Financial Year will end on 30<sup>th</sup> September.
8. Nominations for committee members and Club dignitaries should be sent to the Club Secretary with the name of a proposer and seconder and the agreement of the person nominated at least 7 days before any General meeting.
9. Members wishing to submit an alteration to the Club Rules shall send the same to the Hon. Secretary by 30<sup>th</sup> September prior to the next AGM. Members wishing to submit an item for discussion under any other business shall send the same to the Hon. Secretary at least 7 days prior to any General Meeting.

- v) Compliance Officer

A licensing sub committee of 3 members.  
Three Trustees.

11. Only playing members shall be entitled to vote for Team Captains.
12. DBS Compliance – the Chairman, the Colts Development Manager, the Child Protection Officer, the Club Captain and all teams Captains must hold valid DBS certificates.
13. The names of the following members of the General Committee will be published on the Club website, the Chairman, the Hon. Secretary, the Hon. Treasurer, the Colts Co-Ordinator and the Club Captain. They will receive emails sent to them at the Club's web address.
14. All of the Club's policies and procedures will be published on the Club notice board and the club website.
15. Sale of Intoxicants – the hours for the sale of intoxicants shall be within those prescribed for the land currently applicable and as approved by the Management Committee.  
Members shall have the privilege of introducing visitors to the Club, provided such visitors have not been rejected for membership, requested to resign or expelled by the Management Committee.  
Member's spouses and children shall be deemed honorary members for the purposes of this rule.  
The Management Committee or any member present shall be responsible for the maintenance of good order on the club premises. They shall not permit drunkenness, violence or bad language on the Club premises nor shall they permit the purchase of intoxicants to any person under the age of 18.
